1. The Chief Engineer, (Kaveri), Bangalore Water Supply and Sewerage Board invites tenders from eligible tenderers, for Procurement, Erection, Testing and Commissioning of 1350 kW Motors(6 Nos) for CWSS Stage-I pumping station at Tataguni. Two Cover Tender procedure as per Rule 28 of the KTPP Act shall be followed. The Tenderers are required to pay the Earnest Money Deposit through e-procurement portal only using any of the four modes.
 - a) Credit Card (Online Payment)
 - b) Direct Debit Using Internet Banking (Online Payment)
 - c) Remittance at the Bank Counter - Challan (Offline Payment)
 - d) NEFT (Offline payment).

The Earnest Money Deposit of unsuccessful Tenderers will be returned within 30 days of the end of the tender validity period specified in Sub-Clause 12.1. The Earnest Money Deposit of the successful Tenderer will be discharged when the Tenderer has signed the Agreement and furnished the required Performance Security. The details regarding the capability to undertake the tender (as detailed in Table -A below and Section -2 clause 3 of ITT) and the price schedule shall be uploaded in the website. Technical details will be opened on the date and time mentioned in ITT Section- 2 Clause -19 and evaluated. The price schedule of the Tenderer, who is found to be qualified to execute the tendered works, will be opened on the date notified later. The Tenderers are advised to note the minimum qualification criteria specified in Section -2 Clause 3 of the Instructions to Tenderers to qualify for award of the contract.

I. General work experience: -

- a. The Tenderer as prime contractor should have satisfactorily completed during the last five years i.e., 2015-16 to 2019-20 at least one similar work of procurement, erection, testing and commissioning of 1350kW or above motors to an extent of 50% of the cost of the work value not less than Rs.114.25 lakhs.
- b. Executed in any one year, the following minimum quantities of work: (usually 80% of the peak annual rate of construction) Procurement, erection, testing & commissioning of at least 5 No Motors of 1100 kW, 6.6kV or above in last 5 years in one or more contract.

II. Financial capabilities: -

- a. To qualify for award of this contract, each tenderer in its name should have in the last five years i.e., 2015-16 to 2019-20 achieved in at least two financial years a minimum financial turnover (in all classes of engineering construction works) of Rs.457.00 Lakhs.
- b. Liquid assets and / or availability of credit facilities of not less than Rs.85.70 Lakhs for the above work (Credit Lines/letter of credit / certificates from Nationalized / Scheduled banks in India for meeting the fund requirement etc.),(usually the equivalent of the estimated cash flow for the three months in the peak construction period.)
- c. Assessed available tender capacity = (A x N x 1.5-B) Should not be less than amount put to tender i.e: Rs. 2,28,49,441/-

Where, A = Maximum value of engineering works executed in any one year during the last five years (updated to 2019-20 price level) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the works for which tenders are invited.

B = Value, at 2019-20 price level, of existing commitments and on-going works to be completed during the next 6 month.

Note: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be countersigned by the Employer in charge, not below the rank of an Executive Engineer or equivalent.

III. Equipment capacity : Each tenderer should further demonstrate:

- a. Availability by owning 100% any 2 (50% by owning plus 50% by hiring) of the required / specified key and critical equipment for this work, the relevant documents (Commitment agreements etc) for availability for this work shall be furnished. Some of the equipments are:

IV. Other conditions: -

- a. Form of tender as per KW-4 of KTPP act to be uploaded by the participated tenderer which is mandatory.
- b. EMD amount to be paid as prescribed for the said tender.
5. The last date for uploading of completed tender document on 13/11/2020 up to 15.00hrs
6. The Technical bids will be opened at the office mentioned in para no.12 on after 16:00 hrs in the presence of bidders or their authorized representatives. If the bid opening day remains as public holiday, Bids will be opened on the next working day at the original stipulated time.
7. Bidders can access tender documents from the website and upload the required details; those are mentioned in different sections in the bid document in to electronic tender box on the website. Scanned documents those are required to be furnished as per Section 2, 3 & 4 of the bid document shall be submitted through e-portal preferably in PDF format for clear vision.
8. The cost of the tender document once paid will not be refunded.
9. The successful bidder would be required to give performance Bank Guarantee of 5% of the contract amount plus additional security for unbalanced bid amount from a Nationalized / Scheduled Indian Bank, with jurisdiction at Bangalore as specified in the clause no.29 of ITT, towards guarantee for completion of work within the stipulated period.
10. Applications / requisitions from joint venture Firms are not acceptable.
11. Bangalore Water Supply and Sewerage Board reserves the right to cancel or annul the entire or part of this process of invitation at any time without assigning any reason.
